**Age Relaxation:**

**Age:** The candidate should have minimum age of 18 years and maximum 27 years as on cutoff date i.e. on 31.12.2024.

**Age relaxation –**

for SC/ST - 5 years,

for Other Backward Castes – 3 Years

Land looser - whose land has been acquired by IFFCO factory/ dependents of deceased IFFCO employees – 3 years.

**Qualification:**

- ITI/ Diploma/ B.Sc in Branch / Subjects as specified above will **ONLY** be considered as eligible qualification.
- To apply for Apprenticeship, candidates must have passed ITI examination from an ITI recognized by NCVT
- ITI/Diploma in other than specified Branch / Subjects shall **NOT** be considered.
- The prescribed qualification should be from a recognized Indian University/Institute as a regular full time.
- Candidates possessing higher professional qualifications such as B.E. / B.Tech / MBA / MCA / CA / LLB or any such equivalent qualification shall not be eligible.
- Candidates holding a qualification acquired through part-time / correspondence / distance education mode are not eligible.
- The candidature of the applicant would be provisional and subject to subsequent verification of certificates and testimonials. In case, it is detected at any stage of engagement or thereafter, that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/false information/certificate/ documents or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcomings is/are detected even after engagement, his/her engagement is liable to be terminated.
