Candidates found in-eligible during the scrutiny of documents and not meeting the prescribed eligibility criteria have not been considered towards compilation of result irrespective of marks scored in the online examination.
(iv)	In case of any dispute/ claim regarding publication of this result it shall be within the jurisdiction of Court/ Tribunals in Delhi.
(v)	The candidature of the candidates is provisional and is subject to the verification of Original certificates in support of prescribed essential eligibility criteria (Age, Education, Caste, PwBDs, ESM etc. as applicable) as on the closing date of online application. It should be noted that merely calling candidates for verification of the documents/ medical examination etc. does not, in any way, entitle them for an employment/ appointment in Indian Navy.
(vi)	The provisionally nominated candidates will be sent call letters on registered E-mail ID/ by post as per address mentioned in their online application form by respective cadre controllers. The candidates are to report to the venue as per date and time indicated in the call letter for pre-appointment formalities. Candidates may have to stay for one or two days for completion of verification of documents. Candidates should make their own arrangements accordingly.
