#### • IMPORTANT:-

- Please read all the instructions in this notification carefully and ensure that you meet the eligibility criteria before filling out the online application form. Detailed guidelines for submitting online applications are available on the RRC-WR website: <https://www.rrc-wr.com>.
- Applicants are strongly advised to submit their online applications well before the closing date to avoid potential issues due to heavy website traffic.
- If an applicant does not have a valid personal email ID, they must create one before applying. This email ID must remain active throughout the engagement process.
- This is a Centralized Notification for the engagement of Act Apprentices under the Apprentices Act, 1961, being conducted by Western Railway. The Railway Recruitment Cell, Western Railway has been designated as the nodal agency for receiving online applications.
- Applications must be submitted online only through the RRC-WR website: <https://www.rrc-wr.com>.
- The applicant's candidature will be considered solely based on the information provided in the online application form. Document verification will take place at the respective divisions and workshops.
- In the case of direct recruitment from the open market to Level-1 posts (Pay Scale: ₹18,000 – ₹56,900), candidates who have completed apprenticeship training (CCAA) in Railway establishments and hold a National Apprenticeship Certificate (NAC) will be given preference for up to 20% of the vacancies, subject to fulfillment of the eligibility criteria as prescribed by RRB/RRC.
- Western Railway invites ONLINE applications from interested candidates for engagement as Act Apprentices against **5,349** slots, notified for training in designated trades under the Apprentices Act, 1961, at various Divisions and Workshops under the jurisdiction of Western Railway for the year 2025–26.

#### 1. ELIGIBILITY CONDITIONS:-

##### A. AGE CRITERIA as on 23/03/2026 (Closing date):-

- I. Applicants must have completed 15 years of age and must not have attained 24 years of age as on **23/03/2026**.
- II. **SC/ST Candidates:** Upper age limit relaxed by **5 years**.
- III. **OBC Candidates:** Upper age limit relaxed by **3 years**.
- IV. **Persons with Disabilities (PWD):** Upper age limit relaxed by **10 years**.
- V. **Ex-Servicemen:** The upper age limit is **relaxed by an additional 10 years** for Ex-Servicemen, **plus the length of military service rendered**, and an additional **3 years**, **provided they have completed a minimum of 6 months continuous service** in the Defence Forces.

This age relaxation **does not apply** to Ex-Servicemen who have already secured employment in a **civil post under the Government** after availing Ex-Servicemen status.

- a) An Ex-Serviceman selected under the reservation quota will be **placed in the appropriate category (UR/SC/ST/OBC) to which he belongs.**
- b) Ex-Servicemen, their children, and the children of Armed Forces personnel shall be considered for apprenticeship engagement under the following categories:
  - b.i **Children of deceased or disabled Ex-Servicemen**, including those who were killed or disabled during peacetime.
  - b.ii Children of Ex-Servicemen.
  - b.iii Children of serving Jawans.
  - b.iv Children of serving Officers.
  - b.v Ex-Servicemen.

#### B. ESSENTIAL QUALIFICATIONS:-

Applicants must have already passed the prescribed educational qualification as on the date of issue of this notification, i.e., **18/02/2026**, as detailed below:

##### I. Educational Qualification:-

Applicants must have passed **Matriculation (10th class)** under the **10+2 examination system** with a **minimum of 50% aggregate marks** from a recognized Board.

##### II. Technical Qualification:-

Applicants must possess an **ITI certificate** in the relevant trade, **affiliated to NCVT**, as detailed below:

**Note:-**

- I. **Applicants whose SSC or ITI results are awaited** as of the date of this notification **are not eligible** to apply.
- II. **Applicants who have failed in ITI** should not apply. If any such applicant is inadvertently engaged, **their apprenticeship will be terminated immediately without any further notice.**
- III. **Engineering graduates and diploma holders** are **not eligible** to apply under this notification, as they fall under a **separate Apprenticeship scheme.**

**2. TRADE-WISE APPRENTICESHIP SLOTS:-**

The trade-wise details of applicants to be engaged for training as Act Apprentices, including the category-wise reservation for SC/ST/OBC/EWS and provisions for PwBD/Ex-Servicemen, are provided in **Annexure 'A'**. The trade and Division/Unit-wise breakup of slots is detailed in **Annexure 'A-1'**.

**NOTE:-**

- 2.1** The number of training slots shown in this Notification are provisional and the same are liable to increase or decrease depending upon the actual needs of the Administration at the time of finalization of selection.
- 2.2** There will be a reservation to the extent of 4% for Persons with Benchmark Disabilities (PwBD) and 3% for Ex-Servicemen. These quota slots are included within the overall notified slots and are not to be treated as additional.
- 2.3** Applicants who wish to avail the benefit of reservation under the Ex-Servicemen or Armed Forces Personnel category, including children of Ex-Servicemen and children of Armed Forces Personnel, must upload the appropriate Discharge Certificate or Serving Certificate of their parent, as applicable, at the time of online application.
- 2.4** In case the prescribed number of candidates belonging to the **Scheduled Castes (SC)** are not available, the SC-reserved slots shall be filled by **Scheduled Tribe (ST)** candidates. Similarly, if suitable ST candidates are not available for ST-reserved slots, the same shall be filled by SC candidates. If the slots reserved for SC/ST candidates remain unfilled even after such interchange, they will be filled by candidates belonging to the **Unreserved (UR)** category. Likewise, any seats remaining unfilled under the **OBC** or **EWS** categories shall also be filled by **Unreserved** candidates.
- 2.5** Applicants who wish to avail the benefit of reservation under the SC/ST category must upload their Caste Certificate in the prescribed Central Government format, issued by the competent authority, as per **Annexure 'B'**, at the time of online application.
- 2.6** OBC applicants are required to upload an OBC Caste Certificate along with a Non-Creamy Layer certificate valid for the current year **2025–2026**, in the prescribed Central Government format (as per **Annexure 'C'**), issued on or after **01/04/2025** by the competent authority. The certificate must clearly indicate the caste, date of issue, and bear the official seal of the issuing authority. Additionally, applicants

must mandatorily fill and upload a **Self-Declaration** form regarding their current Non-Creamy Layer status, as per **Annexure 'D'**. Applicants are advised to obtain the latest **OBC certificate with valid Non-Creamy Layer** status for the year **2025–2026**, so that it is readily available for submission at the time of Document Verification.

## **2.7 Reservation for Economically Weaker Sections (EWS)**

Candidates who are **not covered under the reservation scheme for SC/ST/OBC-NCL** and whose **family has a gross annual income of less than ₹8.00 lakh (Rupees Eight Lakhs only)** shall be identified as belonging to the **Economically Weaker Sections (EWS)** for the purpose of availing the benefit of reservation.

The gross annual income shall include income from **all sources**, such as **salary, agriculture, business, profession, etc., for the financial year preceding the year of application**.

The benefit of EWS reservation can be availed **only upon submission of a valid Income and Asset Certificate** issued by a **Competent Authority**, in the **prescribed format as per Annexure 'H'**.

Only certificates issued by any one of the following authorities shall be accepted as valid proof of EWS status:

- District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Additional Deputy Commissioner / First Class Stipendiary Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
- Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate.
- Revenue Officer not below the rank of Tehsildar.
- Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

**Note:-** Candidates applying against vacancies reserved for the EWS category must **possess a valid Income and Asset Certificate as on the closing date of registration** of the application under this notification.

**2.8** Candidates claiming reservation under SC/ST/OBC-NCL/EWS and fail to submit prescribed Community Certificate will not be considered under the respective reserved category. However, if they fulfill all the eligibility conditions prescribed for the General (Unreserved) category, their candidature will be treated as General (UR) only.

## **3. PAYMENT OF FEES:-**

**3.1** The **application fee (non-refundable)** is **₹100/-**.

**3.2** No fee is required to be paid by **SC/ST/PwBD/Women** applicants.

**3.3** The payment of the application fee must be made **online only**, through the payment gateway integrated with the online application process, as detailed below:

- a. Complete the online application form in all respects on the RRC/WR website: [www.rrc-wr.com](http://www.rrc-wr.com).
- b. After ensuring the correctness of the particulars of the application form, Applicants are required to pay fees through the payment gateway integrated with the online application. No change/edit will be allowed thereafter.
- c. The payment can be made by using Debit Card / Credit Card / UPI / Internet Banking etc. by providing information as asked on the screen. Transaction charges for online payment, if any, will be borne by the Applicants.
- d. Once the payment is successfully done, Applicants will be redirected to RRC/WR's website to download the application form.
- e. In case the Applicants makes the payment and faces any issues like loss of internet connection due to which the Applicant is unable to download the application though the fee amount has been

deducted from their Account/Debit/Credit Card, please click on “Verify Payment” button to reconfirm the same from the Payment gateway.

- f. In case after completing the Registration process, the online application fees payment transaction is not successfully completed, please login again and make the online payment again.

#### 4. **MEDICAL FITNESS & PHYSICAL STANDARDS:-**

- 4.1 Candidates who are **shortlisted and called for Document Verification (DV)** must submit a **Medical Certificate** in the **prescribed format** as provided in **Annexure ‘G’**. The Medical Certificate must be **signed by a Government-authorized doctor (Gazetted)**, not below the rank of **Assistant Surgeon** from a **Central or State Government Hospital**.
- 4.2 For Differently Abled Applicants / Persons with Benchmark Disabilities (PwBD), the maximum permissible level of disability has been specified category-wise and trade-wise, as detailed below:

##### a. **Locomotor Disability (LD):-**

<b>Programming &amp; Systems Administration Assistant</b>	Candidates with both lower limbs affected can be accommodated.
<b>Plumber</b>	A person without one or two fingers of the foot and/or hand can be accommodated.
<b>Refrigeration &amp; Air Conditioning Mechanic</b>	i. One lower limb partially functional can be accommodated. ii. Damage to small fingers of both hands can be accommodated.
<b>Draftsman (Civil)</b>	A person partially without both legs or without one leg and with upper left limb damaged can be accommodated.

d. **Multiple Disabilities (MD):-**

Candidates belonging to the **Persons with Benchmark Disabilities (PwBD)** category who have **more than one type of disability** will be classified under the **Multiple Disabilities (MD)** category.

**4.3 Persons with Benchmark Disabilities (PwBD)** who wish to avail the benefit of reservation must **produce a valid Disability Certificate** issued by a **competent authority**, i.e., a **Medical Board** duly constituted by the **Central or State Government**, which must include **at least one specialist** from the relevant field for assessing the disability. The Disability Certificate must be in the **prescribed format as per Annexure-‘E’ and Annexure-‘F’** attached to this notification.

**4.4 Persons with Benchmark Disabilities (PwBD)** candidates with disabilities **other than those specified** in this notification **should not apply under the PwBD category**, as they **will not be eligible** for any reservation, concessions, or facilities applicable to **PwBD** applicants.

**5. TRAINING PERIOD & STIPEND:-**

**5.1 Training Period:-**

Selected applicants shall undergo **Apprenticeship Training for a period of one year**.

**5.2 Stipend:-**

Selected candidates engaged as Apprentices shall undergo apprenticeship training for a period of one year and will be paid a stipend at the prescribed rate during the training period, as per As per extant rules & directives issued by Railway Board from time to time.

**6. MODE OF SELECTION:-**

**6.1** The selection of eligible applicants for training under the Apprentices Act, 1961 will be based on a merit list, which shall be prepared by taking the average of the percentage of marks obtained in both Matriculation (with a minimum of 50% aggregate marks) and the ITI examination, with equal weightage given to both.

**6.2** In the event of two or more applicants securing the same marks, preference will be given to the older candidate. If the dates of birth are also identical, the candidate who passed the Matriculation examination earlier will be given priority. **There will be no written test or viva.**

**6.3** Applicants are not required to send any hard copies of applications, certificates, or documents to RRC/WR by post. All relevant documents must be uploaded online only.

**6.4 Calculation of Marks:**

- a. For the purpose of calculating the percentage of SSC/Matriculation marks, the total marks of all subjects mentioned in the marksheet shall be considered. The calculation must not be based on the 'best of five' approach, but should include all subjects, including optional, additional, and alternate subjects. Applicants with a CGPA must convert it to actual marks and enter the equivalent percentage in the online application. Please note that the final score must be calculated by adding the marks of **all subjects**, and not just a specific group of subjects.

- b. For the purpose of calculating the percentage of ITI marks, the average marks as reflected in the consolidated statement of marks for all semesters of the applied trade as specified in the Provisional National Trade Certificate issued by NCVT shall be taken into account. These marks must be correctly and duly entered by the applicant in the online application.

**Note:-Applicants are advised to note that any discrepancy between the Marks/CGPA entered in the online application and the corresponding entries in the original marksheet or certificate, if detected during document verification, will lead to rejection of their candidature summarily.**

- 6.5** The trade-wise and community-wise merit list will be prepared and issued by the concerned Divisions/Units for their notified slots. Applicants will be called by the respective Division/Unit based on merit in the relevant trade, taking into account the Division/Workshop opted by the candidate. In the event of any shortfall in a particular trade within a given Division or Workshop, Western Railway reserves the right to redistribute candidates to other Divisions/Workshops as deemed necessary.
- 6.6** The final selection of applicants shall be subject to the verification of original documents/testimonials and submission of a Medical Fitness Certificate, as prescribed in **Annexure-G**.
- 6.7** Candidates on the standby list will be issued call letters only upon receipt of details regarding absentees, medically unfit, or rejected candidates from the merit list allotted to the concerned Divisions/Workshops. Call letters will be issued strictly in the order of merit.
- 6.8** Applicants are advised to remain prepared to report to the allotted Divisions and Workshops at short notice for Document / Certificate verification.

## **7. MODE OF APPLICATION : -**

- 7.1** Applicants are required to apply online by visiting [www.rrc-wr.com](http://www.rrc-wr.com). Detailed instructions for filling out the online application will be available on the website.
- 7.2** (a) Applicants are required to fill in their personal details, trade, Aadhaar number, marks/CGPA, and choice of Divisions/Workshopsetc. very carefully, as the computerized merit list will be generated solely based on the information provided in the online application. In case any discrepancy is found during document verification, the applicant shall be summarily disqualified.
- (b) Though, separate slots for Stenographer(English) & PAASA are notified for Mumbai Central Division & HQ office, candidates applying for Mumbai Division and Headquarters Office will be considered through a common application. No separate application is required for Mumbai Division and Headquarters Office.
- 7.3** Applicants must be in possession of an Aadhaar Card. At the time of registration, they are required to enter their 12-digit Aadhaar number. Applicants who have enrolled for Aadhaar but have not yet received the Aadhaar Card may enter the 28-digit Aadhaar Enrolment ID as printed on the Aadhaar Enrolment Slip.
- 7.4** This provision is applicable to applicants from all States and Union Territories. At the time of Document Verification, applicants are required to produce their original Aadhaar Card.
- 7.5** Applicants must ensure that their name, father's name, and date of birth exactly match the details recorded in their Matriculation or equivalent certificate. Any discrepancy found during Document Verification may result in cancellation of candidature and also debarment.
- 7.6** Applicants are advised to provide their active mobile number and valid email ID in the online application and ensure that both remain operational throughout the entire engagement process. All important notifications will be published on the official website, and email/SMS communications will be sent only to the selected applicants. Such communications shall be deemed to have been read by the applicants.
- 7.7** Applicants are permitted to choose only one Division/Workshop. The option once exercised shall be final and binding on the applicant. Applicants are advised to carefully refer to the trade-wise vacancy table

(Annexure A) to verify the vacancies notified and ensure that the Division/Workshop they wish to apply for has available vacancies corresponding to their trade, qualification, community, and category.

- 7.8 Applicants possessing ITI qualifications in more than one trade may apply separately for each relevant trade.
- 7.9 Applicants attempting to submit more than one application for the same trade using different particulars such as Name, Father's Name, Community, PWD status, educational and/or technical qualifications, or different Email IDs/Mobile Numbers are hereby informed that all such applications will be summarily rejected.
- 7.10 Applicants are required to download and retain a printout of their online application, which must be produced whenever requested by the Railway Administration.
- 7.11 Applicants are required to report for Document/Certificate Verification with their original documents, along with the Medical Fitness Certificate (**Annexure-G**), at the designated Division/Workshop/Unit.
- 7.12 Applicants claiming consideration under the EWS quota are required to upload their EWS Certificate, as specified in Para 2.7.

#### 8. **DOCUMENTS TO BE UPLOADED** : -

Applicants are required to upload legible, self-attested scanned copies of the following documents:

##### 8.1 **SSC (Standard 10th)** or its equivalent marksheet.

Certificate as proof of **date of birth**(i.e., SSC/Matriculation certificate or marksheet indicating date of birth).

##### 8.2 **Consolidated ITI marksheet** for all semesters of the trade applied for / Provisional National Trade Certificate indicating marks.

##### 8.3 **National Trade Certificate issued by NCVT**, or Provisional National Trade Certificate issued by NCVT.

##### 8.4 Caste certificate for **SC/ST/OBC** applicants, in the prescribed format as per **Annexures B, C, and D**, wherever applicable, as mentioned in the relevant Para.

##### 8.5 Disability Certificate for **PwBD** applicants, in the prescribed format as per **Annexures E, F, and G**, as applicable.

##### 8.6 Discharge Certificate or Serving Certificate, in case of applicants applying under the Ex-Servicemen quota.

##### 8.7 Income & Asset Certificate (**Annexure H**) to be uploaded by applicants claiming reservation under the Economically Weaker Section (EWS) category, wherever applicable.

##### 8.8 Applicants are required to upload a scanned or soft copy of their recent colour photograph (size: 3.5 cm x 3.5 cm), taken not earlier than three months from the date of application. The photograph must be in JPG/JPEG format, with a resolution of 100 DPI, and the file size should be between 20 KB and 70 KB. The image must clearly show the applicant's front view without a cap or sunglasses. Applicants are cautioned that RRC may reject applications at any stage if the uploaded photograph is found to be old, unclear, or shows significant variation from the applicant's actual physical appearance. Applicants are also advised to keep two additional copies of the same photograph and carry them at the time of Document/Certificate Verification.

##### 8.9 Applicants are also required to upload a scanned or soft copy of their signature (size: 3.5 cm x 3.5 cm) in JPG/JPEG format, with a resolution of 100 DPI. The file size should be between 20 KB and 30 KB.

#### **Note:-**

- a. Certificates issued in languages other than English or Hindi must be accompanied by an attested translated copy in either English or Hindi.
- b. It is mandatory for applicants to **produce the original copies of all uploaded documents, along with two self-attested photocopies**, on the day of Document Verification at the concerned Division.



Applications without the requisite documents uploaded will be summarily rejected. No additional documents will be accepted at the time of Document Verification.

#### **9. INVALID APPLICATIONS / REJECTIONS :-**

Applicants must carefully fill in accurate details and upload all relevant documents. Applications found with the following shortcomings or discrepancies will be rejected at the time of Document Verification:

- 9.1 Application without scanned signature.
- 9.2 Application without scanned photograph.
- 9.3 Application with scanned photograph in which the applicant is wearing goggles, a cap, wig, or coloured glasses, or where the photo is disfigured, too small, or unrecognizable.
- 9.4 Non-possession of the prescribed Matriculation and ITI qualifications for the relevant trade as on the date of application submission.
- 9.5 Absence of relevant certificates as proof for claiming age relaxation or fee relaxation, wherever applicable.
- 9.6 Application without valid proof of age.
- 9.7 Applications submitted by over-aged or under-aged applicants, and/or those with illegible, incorrect, or missing date of birth certificates.
- 9.8 Incorrect / Incomplete applications in any form as and when detected, is liable to be rejected.
- 9.9 Multiple Applications with minor changes of information and / or facts or varied details for same Trade.
- 9.10 Applications without examination fee of Rs. 100/- , wherever applicable or less fee.
- 9.11 Any other form of irregularities as observed and considered as invalid by RRC-WR.
- 9.12 Applications without relevant legible Annexure's as per para8 above.

#### **10. AGREEMENT OF TRAINING:-**

The entire training program under the Apprentices Act, 1961 is governed by the provisions of the Apprenticeship Contract between the employer and the apprentice. The Apprenticeship Contract or Agreement must be submitted to the Apprenticeship Adviser for registration within three months from the date of signing.

- 10.1 Before the commencement of Apprenticeship training in the designated trade, the selected applicants must enter into a Contract of Apprenticeship as per the prescribed provisions.
- 10.2 If the Contract of Apprenticeship is terminated due to the employer's failure to comply with the terms and conditions of the contract, as notified under the Apprenticeship Rules, 1992, the employer shall be liable to pay the apprentice compensation. This compensation shall be an amount equivalent to the apprentice's last drawn stipend for three months.
- 10.3 In the event of premature termination of the Contract of Apprenticeship due to failure on the part of the apprentice to comply with the terms and conditions of the contract (as notified under the Apprenticeship Rules, 1992), the apprentice/surety shall be liable to pay such amount as determined by the Apprenticeship Adviser towards the cost of training. This amount shall be equivalent to the apprentice's last drawn stipend for three months and shall be recoverable from the apprentice or, in the case of a minor, from the guardian.
- 10.4 As per the Apprentices Act, it is not obligatory on the part of the employer to offer employment to the apprentice after completion of the apprenticeship training. Accordingly, apprentices trained in Railway establishments shall have no claim for employment in Railways based on such training, nor shall it be obligatory on the part of the apprentice to accept employment under the employer.
- 10.5 In case the selected applicant is a minor, his/her guardian must enter into a Contract of Apprenticeship with the employer.

#### **11. TEST AND GRANT OF CERTIFICATE:-**

Every Trade Apprentice, upon completion of training, will be granted a Certificate of Proficiency by the National Council, subject to passing a test conducted by the National Council for Training in Vocational Trades to assess proficiency in the designated trade.

12. Apprentices are entitled to **free medical treatment** in case of any personal injury caused by an accident arising out of and during the course of training.
13. **No hostel accommodation** will be provided. The selected applicants must make their own arrangements for accommodation during the training period, in accordance with the provisions of the Apprentices Act, 1961. They will be released upon successful completion of the training.

#### **14. IMPORTANT INSTRUCTIONS:-**

- 14.1 The decision of the Railway Administration in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, and allotment of Division/Workshop shall be final and binding.
- 14.2 No correspondence will be entertained regarding engagement or selection.
- 14.3 Canvassing in any form will result in disqualification of the candidature. No correspondence in this regard will be entertained.
- 14.4 Applicants must ensure that they fulfill all eligibility conditions and other criteria before applying. If found erroneously engaged at any stage, such applicants shall be summarily dismissed without notice.
- 14.5 The candidature of applicants will be cancelled if they fail to produce the required original documents for verification or if any discrepancy is noticed.
- 14.6 Applicants must ensure they meet the eligibility and other criteria before applying. If found ineligible or erroneously engaged, their apprenticeship shall be **terminated** without any prior notice at any stage.
- 14.7 The Railway Administration does not take responsibility for sending replies to applicants who are not selected or not called for. No correspondence regarding the submitted application will be entertained from any individual or organization.
- 14.8 The Railway Administration shall not be held responsible for any inadvertent or typographical errors.
- 14.9 No daily allowance (DA), conveyance allowance, or travelling allowance (TA) will be paid to applicants called for document verification.
- 14.10 After selection for engagement, requests from applicants for change of **Trade, Division, or Workshop** will **not be entertained**. They will be posted **only within the jurisdiction** of the concerned Division/Workshop.
- I Applicants will be trained **only in the trade** for which they have been selected.
  - II Applicants selected for training will **not be permitted to withdraw** from training, except for reasons beyond their control.
  - III Those who **wilfully remain absent** from training shall be **liable to refund** the entire cost of training as well as the **stipend paid**, as determined by the **Central Apprenticeship Adviser**.

#### **15. IMPORTANT ADVISORY:-**

**Applicants will be selected purely on the basis of merit.** Railway Recruitment Cell, Western Railway has not appointed any agents to act on its behalf. Applicants are cautioned not to fall prey to any such claims made by individuals or agencies.

#### **IMPERSONATION / SUPPRESSION OF FACTS – WARNING:-**

- I Any applicant found using unfair means of any kind during the document verification process, such as sending someone else in his/her place or attempting to impersonate, will be **disqualified** from the selection process.

- II Applicants who submit **forged or fake certificates/documents** to secure eligibility or obtain any benefit will face **immediate rejection of their candidature**.
- III Further, applicants are strictly advised **not to bring in or attempt to bring in any political or other influence** to further their interest in the process of engagement. The candidature of such individuals is **liable to be cancelled without any prior notice**.

**16. LEGAL MATTERS:-**
