1. The DSSSB vide advertisement No. 02/22 dated 31/12/2021 with closing date 09/02/2022 read with the notice no. 162-169 dated 03/02/2022, Notice-cum-addendum No. 935-940 dated 02/03/2023, corrigendum No. 2030-37 dated 07/08/2023, corrigendum No. 2038-43 dated 07/08/2023, corrigendum dated 25/01/2024 and other corrigendum/addendum, if any, in respect of post code 802/22 available on Board's website, advertising **109 vacancies (UR-41, EWS-12, OBC-35, SC-14, ST-07 including PwBD: OH-03, HH-08, MD-01, ExSM-01)** for the post of Junior Engineer (Electrical)/Section Officer (Electrical) in various Department under post code-802/22 under Combined Examination Scheme.

2. Further, after unification of North DMC, South DMC and East DMC as Municipal Corporation of Delhi (MCD) w.e.f. 22/05/2022, all results of North DMC, South DMC and East DMC will be declared in the name of Municipal Corporation of Delhi (MCD) as per notice dated 02/03/2023.

3. Vide Notice cum Corrigendum for the Post Codes advertised under Combined Examination Scheme, issued by the DSSSB vide No. 5070-81 dated 19.02.2024, it has to be ensure that - **"The candidate must exercise at least one preference for a Post. Candidates who don't submit their Post Preference(s) within the stipulated time, will not be considered for any Post in the final result. Such candidates shall not be provided another opportunity to exercise preference for Posts"**. Further, **"Final selection and allocation of department by DSSSB shall be based on merit cum preference only. The User Department shall check the eligibility as per RRs and other terms and conditions of the Advertisement Notice"**.

4. The result of online Tier-I examination held on 22/06/2022 was declared vide Notice dated 14/11/2023 & 22/02/2024. 1027 candidates were shortlisted for appearing in Tier-II examination was conducted on 04/03/2024.

5. The marks obtained by **540 candidates** who appeared in Tier-II written examination held on 04/03/2024 has been uploaded on Board's website vide **Notice dated 12/07/2024**. Out of 540, total 245 candidates were shortlisted to select their preference of Departments and upload the documents in e-dossier module –OARS from the period 16/07/2024 to 30/07/2024 subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form. The candidates were also directed to upload duly signed PREFERENCE FORM in e-dossier module. Out of 245 total 233 candidates have uploaded the e-dossiers within the given time. Candidature of rest of the 12 candidates who have not uploaded their e-dossiers within stipulated time have been rejected vide Rejection Notice No. 966 Dated 06/03/2025.

6. As per the provisions of Notice dated 12/07/2024, allocations of the post to eligible candidates have been made on the basis of Merit-cum-Preference of posts submitted by the candidates in their PREFERENCE FORM uploaded in e-dossier OARS module. Once a post/department is allocated, no change of posts will either be entertained or allowed by the Board.

7. As per the Board (DSSSB) resolution dated 14.7.2022, DSSSB shall neither undertake scrutiny of documents uploaded by the shortlisted candidates in their e-dossier nor check the eligibility of the candidates as per the Recruitment Rules for the post or the terms and conditions stipulated in the Vacancy Notice relating to age, experience, educational qualification, reserved category status, PwD status etc. These will be checked by the User Department at the time of Document verification for deciding the eligibility of the candidate for the post Code 802/22 as on cut-off date 08.02.2022, before issuance of offer of appointment to the candidate.

8. On the basis of marks secured in the written examination and considering other relaxations, if any, claimed by the candidates in their online application forms, **Total-100 (UR-37 including PwD/HH-01, OH-01, EWS- 12 including PwD/OH-01, OBC-31, SC-13 including PwD/OH-01, ST-07)** candidates are hereby provisionally nominated for the Post under Post Code 802/22 subject to fulfillment of all other conditions of eligibility and also correctness of the information furnished by the candidate in his online applications form and e-dossier. 09. The provisional nomination of the above **Total-100 (UR-37 including. PwD/HH-01, OH-01, EWS- 12 including PwD/OH-01, OBC-31, SC-13 including PwD/OH-01, ST-07)** candidates on the basis of claim in their applications shall be subject to thorough verification of their candidature by the User Department including the identity of the candidate as per services department Circular No. F.16(3)/2007/S-III/1756-1763 dated 02/08/2021.

10. The provisional nomination of the above **Total-100 (UR-37 including. PwD/HH-01, OH-01, EWS- 12 including PwD/OH-01, OBC-31, SC-13 including PwD/OH-01, ST-07)** candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications



and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. by the User Department. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

12. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

13. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

14. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong





to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

15. The User Department shall also get the EWS certificates verified from the Issuing authority. Further, the User Department shall also verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority as per instruction of DoPT O.M. No. 36039/1/2019-Estt (Res) dated 31.01.2019.

16. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54 and other relevant.

17. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

18. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User Department is satisfied after such inquiry as may be considered necessary that the candidates is suitable in all respects for appointment to the post.

21. The User Department being Cadre Controlling/Appointing Authority shall strictly follow the merit-based ranking of the candidates in the main list.

22. The User Department Shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98-Estt (Res) dated 01/07/1998 and 430111/4/2018-Estt (Res) dated 04/03/2018 regarding shifting of candidates from respective reserve categories to the un-reserve category, if required.

23. P & P Branch vide its Notice No. 5070-81 dated 19/02/2024 has confirmed again that there will be No waitlist/reserve panel maintained. The post code will be closed after declaration of the result without providing the wait list/reserve panel.

24. The above result for the post of JUNIOR ENGINEER (ELECTRICAL)/SECTION OFFICER (ELECTRICAL) under Post Code -802/22 is subject to outcome of pending court case, if any.
